




Figure 12: Step 5 of the Employee Performance Assessment and Feedback System Toolkit

### Task 2: Monitor the Implementation

Your organization will want to gather information about things that have gone well/not well with the pilot.

In addition, your organization might ind it helpful to consider whether the innovation that you introduced has had an impact on other Levers for Change in the equity of your Employee Performance Assessment and Feedback System. For example, if the pilot innovation tested by your organization focused on the assignment of oversight roles and accountabilities for employees' fair access to employee performance assessment and feedback, your organization might want to think about whether it should adopt an innovation related to data collection (that is, the Planning and Evaluation Lever for Change) in the Employee Performance Assessment and Feedback System. 


Figure 14: Impact of Innovations on Levers for Change


