- Contributing buildings ithin the area are considered to be all buildings that are more than 50 ears old and retain integrit .
- y *Pama Gardens (BOS.JZ)* This area consists of nine residential apartment buildings. The MHC did not comment on the National Register eligibilit of this area.
- y Upper Foster Street Area (BOS.JY) The Upper Foster Street Area contains set eral residential subdet isions that date bet een 1914 and 1940 as ell as a small number of 19th centur houses, mainl on Foster Street, that pre-date this period. The MHC has made the opinion that this area meets the criteria for listing in the National Register of Historic Places.²
- Upper Chestnut Hill-E ergreen Area (BOS.JX) The Upper Chestnut Hill-E ergreen
 Area as determined b the BLC (No ember 2006) to be 2 1 TfAl-6.2(0)2(tfor listing in the N TJ-T 0.0

New Construction

Planned construction on the Brighton Campus includes the follo ing (see Chapter 5, *Proposed Institutional Projects*):

- y The Brighton Athletics Center, hich includes intercollegiate baseball and softball fields, one intramural pla ing field and support facilities. The existing site consists of pla ing fields and no structures ill be impacted by the delegate elopment of the complex.
- y A ne 500-space parking garage on a currentl under eloped site just south of Brighton Athletics Center project.
- y A 14,000 sf Librar Storage building just north of the existing Seminar Librar .

 Construction of Librar Storage building ma hare a isual impact on the Seminar Librar .
- y A Fine Arts District, consisting of an approximatel 55,000 sf Fine Arts/Museum complex of linked buildings of four to fire stories and a height of 60 feet, and an approximatel 30,000 sf auditorium ith 1,200 seats, primaril for Unir ersit use. This district ill be located on Common ealth Arrene bet een the former Cardinal's Residence and the former Creagh Librar. These ne buildings ma hare arrene impact on the former Cardinal's Residence and the former Creagh Librar.

No archaeological in estigations has e been conducted on the Brighton Campus. To date no archaeological resources has e been identified that ould be impacted by the proposed institutional projects. Boston College ill conduct an intensite (locational) archaeological sure e of the campus after consulting ith MHC on the appropriate methodolog, should an of the projects require state in or ement.

Renovation of Existing Buildings

Boston College plans to reno ate for e buildings on the Brighton Campus. One of those buildings is St. William's Hall, hich as added to the existing Boston College IMP in an IMP Amendment appror ed in 2006. Reno ations are also planned for the STM Librar (former Seminar Librar), Bishop Peterson Hall, the Chancer and the Creagh Librar. The proposed reno ation of the STM Librar is addressed in an IMPNF for an IMP Amendment and a PNF submitted b Boston College to the BRA on October 12, 2007. The reno ation of Biso1 T.80. Demolition

The onl demolition on the Brighton Campus currentl anticipated in the next 10 ears is the St. John s Seminar Ser ice Building (MHC #BOS.15234), hich is a contributing element of the Chancer -St. John s Seminar Complex. Boston College plans to demolish the ser ice building and create landscaped open space to replace open areas lost to ne construction and to create a buffer bet een the planned garage and adjacent residential properties. The ser ice building as constructed in the 1960s and ser es as a garage and maintenance building. It as identified as a contributing element of the Chan

- Chestnut Hill Historic District (NWT.O, NWT.AJ, and NWT.EG) is listed in the National Register of Historic Places (September 4, 1986 and Februar 16, 1990) and is a local historic district regulated b the Chestnut Hill Historic District Commission. The Chestnut Hill Historic District contains approximatel 168 properties and is located immediatel south of the Boston College Chestnut Hill Campus. The Chestnut Hill Historic District also contains a number of buildings that are currentle of need be the Unit ersite, including the entire Hammond Triangle area.
- Y Common ealth A enue Historic District (NWT.AB) is listed in the National Register of Historic Places as an historic district (Februar 16, 1990) and is included in the Ne ton NR MRA 1908-1940 (Februar 16, 1990). The Common ealth A enue Historic District contains 321 properties and is located immediatel north and est of the Boston College Chestnut Hill Campus and does not include an resources associated ith the MBTAs stem. MHC noted that the additionall consider that the eastern boundar of the district (hich currentle terminates at Mt. Al ernia and near Algonquin Road in Ne ton) should actuall extend to the Boston-Ne ton cit line in order to include the entiret of the Common ealth A enue historic Carriage a .6
- Monadnock Road Historic District (NWT.AE) is listed in the National Register of Historic Places as an historic district (Februar 16, 1990) and is included in the Ne ton NR MRA 1908-1940 (Februar 16, 1990). It contains 89 properties and is located immediatel est of the Boston College Chestnut Hill Campus.
- y Quinc Road Ma flo er Road Priscilla Road Old Colon Road Area (NWT.BA) is an in entoried area immediatel est of the Boston College Chestnut Hill Campus and includes a number of properties that are currentle of ned be the Unit ersite. The Area Form does not indicate homman properties are included in the Area.
- y There are also a number of ind idual in entoried properties (not located in areas or historic districts) that are located immediatel north and est of the Chestnut Hill Campus.

Unlike the Brighton Campus, the Chestnut Hill Campus as subject to a reconnaissance archaeological and architectural sure in 1994 in conjunction ith the precious Boston College IMP. The sure identified areas that ere considered to be archaeologicall sensite e and, as a result, the MHC requested that the be subject to additional archaeological sure e.
